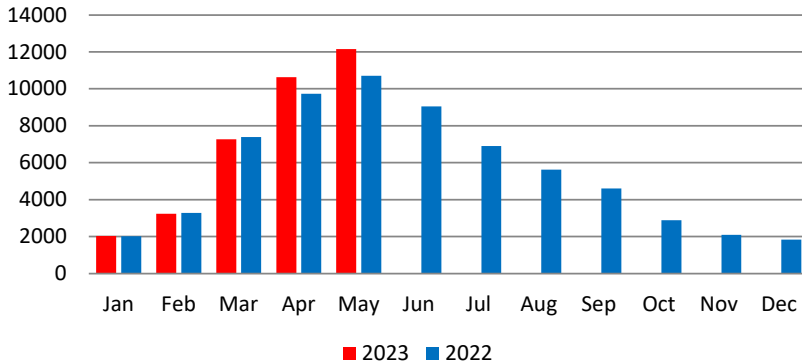


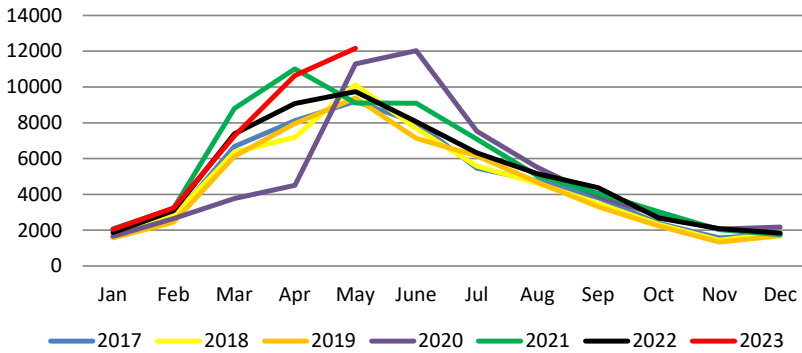

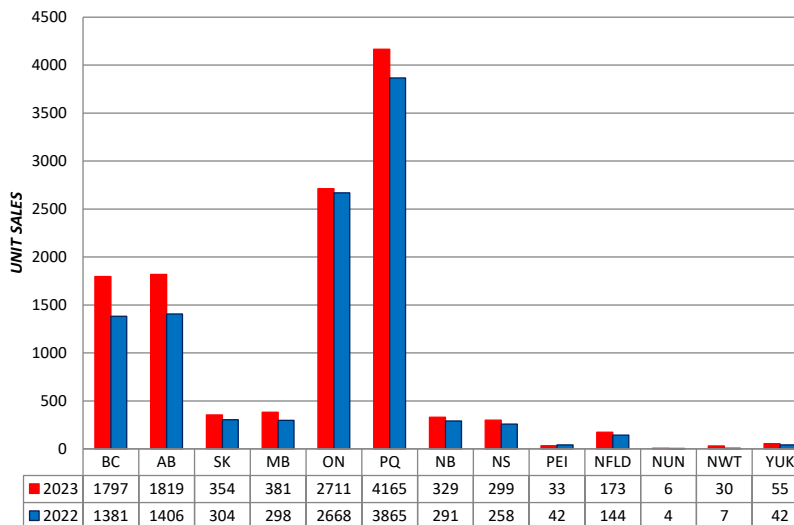
2023 vs 2022 Motorcycle

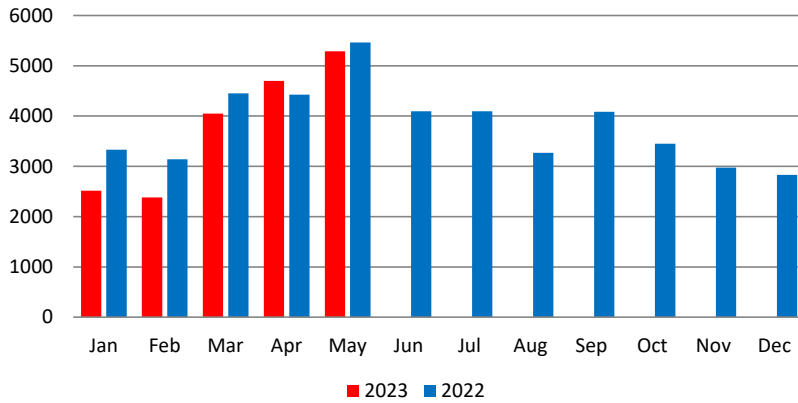

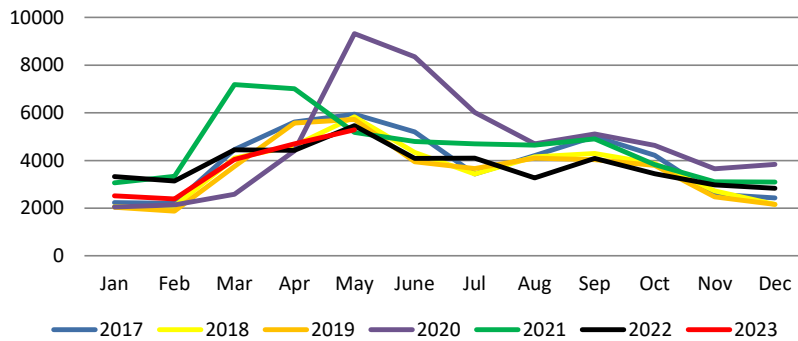

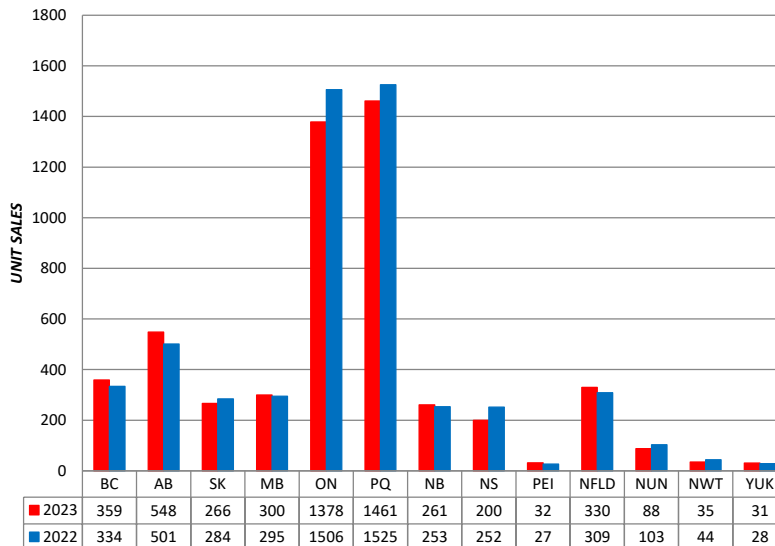
ATV Sales 2023 VS 2022
