#### Introducing the PEI ATV Federation

As the warm summer breeze sweeps across Prince Edward Island, we're excited to bring you the latest updates from the PEI ATV Federation Our eight clubs have become the backbone of our thriving community, working tirelessly to create a network of trails that connect riders to the island's picturesque landscapes. The collaborative efforts of our clubs have led to the development of approximately 550 kilometers of trails, offering adventure seekers a chance to explore the island like never before. A crucial component of expansion has been the pilot road project which utilizes low traffic, dirt roads.



Our commitment to education and safety has never been stronger. In 2022, a remarkable 2850 trail passes were sold, reflecting the growing interest in responsible ATV riding. We believe that

with every trail pass, we're not just granting access to the great outdoors but also promoting a culture of safety and respect. Our effective social media presence has been instrumental in spreading awareness about safe riding practices, trail etiquette, and environmental consciousness. We're not just riders; we're responsible stewards of the land. The importance of social media is more important than ever! Our federation has on staff, a social media manager and the role has proven invaluable when it comes to sharing information and pushing a consistent message of safety. Our member clubs have also established social media pages and have seen great success in event advertising, online fundraising and relaying crucial information about trail closures, maintenance, etc. Social media has become a hub for enthusiasts to ask questions, organize runs and share information about the trails.

What sets us apart from the rest of Canada is our unique trail landscape. With 90% of our trails located on private land, our partnerships with landowners are invaluable. Our member clubs work extremely hard to maintain these relationships. Because of these relationships member clubs and landowners are more often than not, able to effectively find a way to keep active trails open. The Environmental Code of Practice (ECOP) (<u>https://ridepei.ca/wp-ontent/uploads/2023/01/</u> <u>Enviromential-Code-of-Practice.pdf</u>) has allowed us to create a sustainable and mutually beneficial relationship too. The PEI ATV Federation is the only trail user group on PEI that has and operates under the guidance of an environmental code of practice. It's a testament to our commitment to responsible, sustainable and environmentally friendly trail building.

The province will be introducing annual registration in 2024 which will give our member clubs the resources they so desperately need to expand and maintain their trail systems, and our strategic plan continues to guide our path (<u>https://ridepei.ca/resources/</u>). Furthermore, our partnership with Tourism PEI has led to the prioritization of Winter ATV Tourism, culminating in a potential regional pilot project connecting three clubs in West Prince. This pilot project will be the

first of its kind on PEI. If you weren't aware, PEI does not have a shared trail system so this project would be the first to actively explore shared trail usage. We are in the final stages of a Tourism Feasibility Study which will help us determine the economic impact that ATV tourism brings to our island communities. From this study there will be a 3-year action plan that will help us chart this new territory.

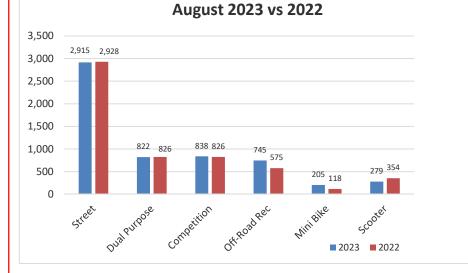

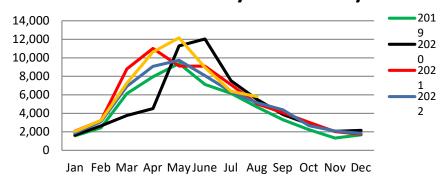

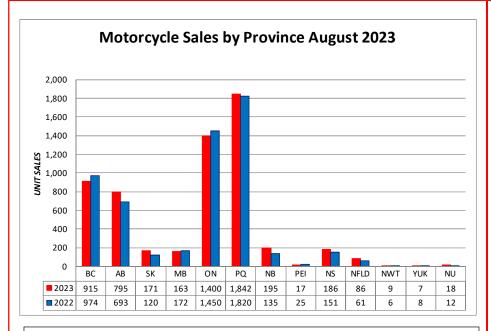
